I, THE UNDERSIGNED, UNDERSTAND THAT Hawaii law (Act 249, 1994 Hawaii Legislative Session, Effective June 29, 1994) limits the civil liability of persons sponsoring equine (horse, pony, mule, donkey, hinny) activities.
